<u>My Four Areas of Focus</u> <u>on the</u> <u>AILA Board of Governors</u>

- Member Service and Accessibility My decade-long commitment to agency liaison work has been highlighted by a focus on responsiveness and addressing specific concerns of individual AILA members. This will continue to be my approach on the AILA Board of Governors. The Board needs to be committed to member service, and I have shown that commitment for more than a decade.
- 2. <u>Advocacy</u> We are at a critical point regarding the potential for changes to our core immigration laws. From business, to family, to laws relating to undocumented immigrants, we could see a massive revision of the law. This could be a very good thing, or it could be a very bad thing not just for us and our clients, but for the American economy. AILA leadership needs to be made up of people who have specific and direct experience in effective policy advocacy, which is something I have been doing for 15 years. I'll bring this expertise to the Board to help AILA continue to be the leading voice in this debate.
- 3. <u>Ensuring Coordinated Efforts</u> AILA members have diverse interests, but they are not mutually exclusive. AILA is the glue that holds these diverse interests together, and AILA must continue to be a strong advocate for business immigration reforms while also being a strong advocate for human rights and justice for those who are the most vulnerable. To do so, it is critical that the Board evaluate the dynamics of the current political environment, and that its leaders consider all aspects of advocacy strategy to best advance all of the interests of its members. Ensuring these coordinated efforts will be one area in which I will focus on the Board.
- 4. <u>Resources</u> AILA is the single most important source of legal resources for most immigration practitioners. When I began practicing immigration law, I was at a small firm and was the only lawyer at the firm who had an immigration practice. AILA was critical for me as a resource. We need to ensure that all AILA members continue to have access to these resources. Webinars, practice advisories and alerts, and similar activities are critical in all areas of the law. Substantive, in-depth chapter conferences like the ones held by a number of chapters each year are something AILA needs to promote and encourage. We need to ensure that AILA is bringing resources to its members, rather than asking members to seek them out.
