10:20 - 11:10 *!Uno, Dos, Tres—Knock Out! Immigration cases from the last Supreme Court Term: Reyes Mata v. Lynch and Mellouli v Lynch*

Sheridan Green, *Gonzalez Olivieri LLC, Houston TX*

Sheridan Green graduated with a bachelor's degree in classical studies from Brigham Young University in 2007. He graduated cum laude from South Texas College of Law in 2012 where he was a member of the law review and worked 2 semesters in the immigration clinic.
