Dear Kelli,

Hope you're well!

I wanted to contact you because as part of our national media outreach efforts, we are planning a national Radio tour featuring interviews with our executive and media advocacy committee members. We would like to invite someone from the Texas/Oklahoma chapter to participate since it's an important radio market and reached out to you first as Media Liaison for the chapter.

We'd like to conduct the interviews on Thursday, December 3 and Friday, December 4. They will last approximately 5-15 minutes and will be conducted by our wonderful radio producer Chris Michael. He'll take them, package them, and get them out to stations all around the country. I'll need three things from you:

1. The person who is interested in participating.
2. Their schedule on 12/3 and 12/4 between 11a.m. and 6p.m. Eastern Time (8-3p.m. Pacific).
3. A landline number for Chris to call for the interview, as well as a backup in case there's any problem.

The focus of the interview will be the report card recently issued by AILA regarding President Obama's immigration actions; below is a sample script – we'll send you a confirmation email with the final script the day before your interview. Note that, like the Hometown radio tour during National Day of Action, the script is just a guide. Draft script/talking points for radio tour interview:

Chris: Immigration issues continue to be top of mind and everyone looks to see what President Obama will do next, but what has he done thus far and what could he do in his last year as president? Here to tell us more is XXX, an attorney from XXX:

AILA member: A year ago, President Obama announced a series of executive actions he would take on immigration since Congress wasn't moving forward.

AILA member: The American Immigration Lawyers Association took a hard look at what's been accomplished and issued a report card for the president. His track record has really been mixed. On humanitarian protection and family detention, he has failed. On changes to the legal immigration system, the best we could give him was an incomplete. On Enforcement, he earned an unsatisfactory. The only bright spot really was his efforts to grant relief for the undocumented with strong ties to the U.S. – in that area he earned a good effort.

Chris: What one change would you most like to see over the next year?
